ENROLLMENT CONTRACT AND RELEASE

Tennessee
Blount County

This enrollment contract and release, entered into this day of _____, 20____, by and between Artistic Dance Unlimited, a Corporation with offices and principle place of business in Alcoa, Blount County, Tennessee (hereinafter “the studio”), and _____ parent(s), (hereinafter the “parents”).

1. Parents hereby enroll _____ (student’s name) in the studio for dance instruction, and tender herewith the NONREFUNDABLE registration fee of Twenty-five (\$25.00).
2. No refunds or make-up classes will be given for classes missed by students. However, classes missed due to illness of teacher, inclement weather closings, or unforeseen emergencies may be made up on a scheduled date (to be announced by instructor).
3. **ALL TUITION PAYMENTS ARE DUE THE FIRST CLASS OF EACH MONTH. A \$10.00 LATE FEE WILL BE CHARGED TO THOSE ACCOUNTS RECEIVING PAYMENTS AFTER THE 10TH OF THAT MONTH. THERE WILL BE A \$25.00 FEE ON ALL CHECKS RETURNED BY A FINANCIAL INSTITUTION FOR NSF. A 3.75% CONVENIENCE FEE WILL AUTOMATICALLY BE ADDED TO ALL CREDIT CARD TRANSACTIONS.**
4. **A notice is required prior to cancellation of enrollment. If notice is not submitted before the first day of the month, parents will be responsible for tuition for that month. No refunds will be given on tuition due to cancellation of enrollment.**
5. In consideration of the forgoing instruction performed by the studio for their child or children, an other valuable consideration, parents hereby assume all risks to their child or children in connection with the dance instruction and studio, and further release the studio, instructors, program, agents, and operators, for any injury or damage which may befall their child or children while said child or children are enrolled as a student of the studio, including risks connected therewith, whether foreseen or unforeseen, and further parents shall indemnify and hold the studio and its agents and employees harmless from any claim made by the parents or be the parents in behalf of their child or children for any liability, of whatsoever nature, for any accidents or injuries suffered or incurred by the child or children, including court costs, expenses, and reasonable attorney fees.
6. The dance studio does not carry medical insurance for students. It is required that all dance students be covered by their own family insurance policies and if injury occurs it is understood that the student’s own policy is the only source of parent’s reimbursement.
7. Parents give permission for their child/children to be photographed or video taped during but not limited to, performances sponsored by the studio throughout the enrollment year.
8. Costume fees. Costumes fees vary between \$65.00-\$85.00 per class routine (i.e.-one costume for ballet and one costume for tap). A \$30.00 per costume deposit is required to be due in September. Then again a \$30.00 per costume deposit required in November. After deposit has been made and costumes ordered, parents are required to pay the balance for the costumes, due in January, regardless of any circumstances. Costumes may not be returned for any reason after delivery of said costumes. Costumes will not be delivered to parents or students until all accounts have been paid in full (including May tuition).
9. All students are required to participate (if possible) in our annual spring performance on Friday June 1st and Saturday June 2nd 2018 at the Clayton Center for the Arts. A recital fee will be charged to cover cost of producing the show and ticket prices for the show will range from \$14-\$16 per ticket.
